POWELL RUN & GUN BASKETBALL TOURNAMENT 2017

TOURNAMENT RULES

National Federation of State High School Association Basketball Rules will apply with the following exceptions:

1. Games will consist of two, 20 minute halves. A running clock will be used. The clock will stop on time outs, free throws, and on all whistles during the last two minutes of the game.
2. Overtime periods will consist of two minutes. The clock will stop on all whistles. The third overtime will be sudden death. The first team to score wins.
3. Time outs: Each team will be allowed three, one minute time outs per game. Teams will be given one time out per overtime. Time outs will not be carried over into overtime.
4. Half time will consist of three minutes.
5. The 3 point shot will be allowed for all divisions.
6. Teams will not be allowed to play zone defenses at any time. Full court presses will only be allowed during the last two minutes of the game. A warning will be issued for the first violation. Further violations will result in one free throw and possession of the ball to the offended team.
8. Players may only play in their grade division or higher, but may only compete for one team.
9. Roster additions or deletions must be completed prior to the team's first game. Emergency additions may be allowed by the tournament director or gym supervisor.
10. Uniforms: Teams must have numbered uniforms of similar color. Two separate colors are recommended.
11. Shoes: Shoes worn into a facility will not be allowed on any of the courts. Game shoes must be non-marking.
12. Game balls will be provided. All divisions will use the women's size (28.5). Warm up balls will not be provided.
13. Conduct: At the discretion of the tournament director and/or gym supervisor, a team may be suspended from further play for unsportsmanlike behavior by its players, coaches, managers or fans. Any coach receiving 2 unsportsmanlike technical fouls during the tournament will be ejected for the remainder of the tournament.

I further agree to indemnify and hold harmless PR&G and others listed for any and all claims arising as a result of my engaging in activities or any activities incidental thereto, wherever, whenever, or however the same may occur.

I understand that this waiver is intended to be as broad and inclusive as permitted by the laws of Wyoming and agree that if any portion is held invalid, the remainder of the waiver will continue in full legal force and effect. I further agree that the venue for any legal proceedings shall be in Wyoming.
